About Us

The World Customs Organisation (WCO) headquartered in Brussels, Belgium represents 183 Customs administrations worldwide. As information and intelligence exchange is one of the pillars of the WCO enforcement strategy, a global network of Regional Intelligence Liaison Offices (RILOs) was established. Eleven RILO offices are covering the six WCO regions. The RILO is a regional center for collecting and analysing data as well as for disseminating information on trends, modus operandi, routes and significant cases of fraud.

Our Region

The Regional Intelligence Liaison Office Western Europe (RILO WE) serves as a regional contact point for intelligence analysis and a liaison point for enforcement cooperation with the 22 customs administrations in its region.



Our Mission

The RILO WE supports its member administrations by

- Providing regional analysis
- Providing target-oriented alerts/warning messages
- Facilitating regional cooperation and information exchange
- Developing and maintaining regional Customs projects
- Organizing, coordinating and supporting (joint) Customs and Police operations

The RILO network uses the CEN database and other sources to analyse seizures and develop regional intelligence products. The CENcomm platform serves to exchange operational information and facilitate secure communications among members and partners.

- Web based database containing non-nominal worldwide customs seizure information for the analysis of illicit trafficking
- Read-only access available for all customs officers on request and approval
- More than 2,000 active users in more than 155 countries
- Contains a Concealment Picture Database (X-Ray images included)
- Includes Enforcement Website for global alerts and bulletins

A WEB BASED COMMUNICATION TOOL

- Exchange and dissemination of information in a secured environment
- A closed user group of officers can communicate via encrypted channels during operations/projects
- Direct access available 24/7
