TERMS	GLOSSARY OF INTERNATIONAL CUSTOMS TERMS
<p>ADMINISTRATIVE SETTLEMENT OF A CUSTOMS OFFENCE (Règlement administratif d'une infraction douanière)</p>	<p>The procedure laid down by national legislation under which the Customs are empowered to settle a Customs offence either by ruling thereon or by means of a compromise settlement.</p> <p><i>Note</i> Administrative settlement of a Customs offence is dealt with in Annex H.2 to the Kyoto Convention of 1974 and Specific Annex H, Chapter 1 of the revised Kyoto Convention.</p>
<p>AD-VALOREM DUTIES AND TAXES (Droits et taxes ad valorem)</p>	<p>Duties and taxes which are calculated on the basis of value.</p>
<p>ADVANCE RULINGS (Décision anticipée)</p>	<p>A written decision issued by a competent authority to the applicant prior to an import or export transaction of goods covered by the application that sets forth the treatment that the Member shall provide to the goods at the time of an import/export transaction, for a specified period.</p> <p><i>Notes:</i></p> <ol style="list-style-type: none"> 1. Advance rulings are dealt with in Article 3 of the WTO Agreement on Trade Facilitation. 2. Advance rulings are provided for under the revised Kyoto Convention standard on "binding rulings" (General Annex, Standard 9.9) as well as in the WTO Agreement on Rules of Origin ("assessments on origin"). Some Customs administrations may refer to advance rulings as "preliminary decisions"; "binding tariff information" or "binding origin information".
<p>AIRCRAFT GENERAL DECLARATION (Déclaration générale de l'aéronef)</p>	<p>Declaration conforming to the provisions of Annex 9 to the Convention on International Civil Aviation, Chicago 1944. The general declaration is the basic document on arrival and departure providing information concerning the aircraft itself and summary information relating to the itinerary, crew, passengers and health.</p>

<p>APPEAL (Recours)</p>	<p>The act by which a person who is directly affected by a decision or omission of the Customs and who considers himself to be aggrieved thereby seeks redress before a competent authority.</p> <p><i>Note</i></p> <p>Appeal in Customs matters is dealt with in Annex H.1. to the Kyoto Convention of 1974 and the General Annex, Chapter 10 of the revised Kyoto Convention.</p>
<p>ASSESSMENT OF DUTIES AND TAXES (Liquidation des droits et taxes)</p>	<p>Determination of the amount of duties and taxes payable.</p> <p><i>Note</i></p> <p>Assessment of duties and taxes is dealt with in the General Annex, Chapter 4 of the revised Kyoto Convention.</p>
<p>ATA CARNET (Carnet ATA)</p>	<p>An international Customs document which, issued under the terms of the ATA Convention and the Istanbul Convention, incorporates an internationally valid guarantee and may be used, in lieu of national Customs documents and as security for import duties and taxes, to cover the temporary admission of goods and, where appropriate, the transit of goods. It may be accepted for controlling the temporary exportation and re-importation of goods but, in this case, the international guarantee does not apply.</p> <p><i>Notes</i></p> <ol style="list-style-type: none"> 1. The ATA carnet may not, in principle, be used for the temporary admission of means of transport (See Commentary 2 to Article 1, Annex A of the Istanbul Convention). 2. Instead of "import duties and taxes" the ATA Convention uses the term "import duties", giving it the same scope as the Glossary gives to the former expression.
<p>ATA CONVENTION (Convention ATA)</p>	<p>The expression commonly used to refer to the Customs Convention on the ATA carnet for the temporary admission of goods (ATA Convention) adopted by the Customs Co-operation Council in Brussels in 1961.</p>
<p>AUDIT-BASED CONTROL (Contrôle par audit)</p>	<p>Measures by which the Customs satisfy themselves as to the accuracy and authenticity of declarations through the examination of the relevant books, records, business systems and commercial data held by persons concerned.</p> <p><i>Note</i></p> <p>Audit-based control is dealt with in the General Annex, Chapter 6 of the revised Kyoto Convention.</p>

TERMS	GLOSSARY OF INTERNATIONAL CUSTOMS TERMS
<p>AUTHORIZED ECONOMIC OPERATOR (AEO) (Opérateur Economique Agréé - OEA)</p>	<p>AEO is a party involved in the international movement of goods in whatever function that has been approved by or on behalf of a national Customs administration as complying with WCO or equivalent supply chain security standards. AEOs may include manufacturers, importers, exporters, brokers, carriers, consolidators, intermediaries, ports, airports, terminal operators, integrated operators, warehouses, distributors and freight forwarders.</p> <p><i>Note</i></p> <p>1. Authorized Economic Operator (AEO) is dealt with in the WCO SAFE Frameworks of Standards.</p>

<p>BOARDING AND SEARCH OF MEANS OF TRANSPORT (Contrôle à bord et visite des moyens de transport)</p>	<p>The operations under which means of transport are visited by the Customs for:</p> <p>(a) collection of information from the person responsible for the means of transport and examination of commercial, transport or other documents concerning the means of transport, the cargo, stores, crew and passengers; and</p> <p>(b) inspection, examination and search of the means of transport.</p>
<p>BOND (Soumission)</p>	<p>An undertaking in due legal form, by which a person binds himself to the Customs to do or not to do some specified act.</p>

<p>CARGO DECLARATION (Déclaration de chargement)</p>	<p>Information submitted prior to or on arrival or departure of a means of transport for commercial use that provides the particulars required by the Customs relating to cargo brought to or removed from the Customs territory.</p> <p><i>Notes</i></p> <ol style="list-style-type: none"> 1. The nature and contents of Cargo declarations may vary from country to country according to the commercial means of transport used. The particulars of the cargo (freight) may include kind, number, marks and numbers of packages, brief description of the goods, gross weight, etc. In some countries, these particulars may be submitted by electronic means. 2. Cargo declarations are often referred to as "manifests"; in some countries Aircraft cargo manifests, Ship's manifests or Goods manifests are accepted in place of the Cargo declarations. Cargo declarations are also sometimes referred to as freight declarations. 3. The Annex to the Convention on Facilitation of International Maritime Traffic, London, 1965, provides for a Cargo declaration (Model Form IMO FAL Form 2). With regard to air transport, the corresponding declaration is called Cargo manifest (Model Form as on International Civil Aviation, Chicago, 1944) 4. Goods declarations may subsequently be presented in respect of the individual consignments covered by the Cargo declarations. 5. Cargo declaration is defined in Specific Annex A, Chapters 1 and 2 of the revised Kyoto Convention.
<p>CARGO MANIFEST (Manifeste de chargement)</p>	<p>A listing of the goods comprising the cargo (freight) carried in a means of transport or in a transport-unit. The Cargo manifest which gives the commercial particulars of the goods, such as transport document numbers, consignors, consignees, marks and numbers, number and kind of packages, descriptions and quantities of the goods, may be used in place of the Cargo declaration.</p> <p><i>Note</i></p> <p>Examples of Cargo manifests are Aircraft cargo manifests, Ship's manifests, Goods manifests and "bordereaux" (road traffic).</p>
<p>CARRIER (Transporteur)</p>	<p>The person actually transporting goods or in charge of or responsible for the operation of the means of transport (*).</p> <p>(*). Annex A.1. to the Kyoto Convention of 1974 and Specific Annex A, Chapter 1 and Specific Annex J, Chapter 4 of the revised Kyoto Convention.</p>

TERMS	GLOSSARY OF INTERNATIONAL CUSTOMS TERMS
<p>CERTIFICATE OF ORIGIN (Certificat d'origine)</p>	<p>A specific form identifying the goods, in which the authority or body empowered to issue it certifies expressly that the goods to which the certificate relates originate in a specific country. This certificate may also include a declaration by the manufacturer, producer, supplier, exporter or other competent person.</p> <p><i>Notes</i></p> <ol style="list-style-type: none"> 1. In this definition the word "country" may include a group of countries, a region or a part of a country. 2. Specific forms for certificates of origin have been laid down in Annex D.2. to the Kyoto Convention of 1974 and Specific Annex K, Chapters 2 and 3 of the revised Kyoto Convention and in the framework of preferential arrangements such as the Generalized System of Preferences.
<p>CERTIFIED DECLARATION OF ORIGIN (Déclaration certifiée de l'origine)</p>	<p>A declaration of origin certified by an authority or body empowered to do so (*).</p> <p>(*) Annex D.2. to the Kyoto Convention of 1974 and Specific Annex K, Chapters 2 and 3 of the revised Kyoto Convention.</p>
<p>CHECKING THE GOODS DECLARATION (Examen de la déclaration de marchandises)</p>	<p>The action taken by the Customs to satisfy themselves that the Goods declaration is correctly made out and that the supporting documents required fulfil the prescribed conditions (*).</p> <p>(*) General Annex, Chapter 2 of the revised Kyoto Convention</p>
<p>CLEARANCE (Dédouanement)</p>	<p>The accomplishment of the Customs formalities necessary to allow goods to enter home use, to be exported or to be placed under another Customs procedure (*).</p> <p>(*) General Annex, Chapter 2 of the revised Kyoto Convention.</p>
<p>CLEARANCE FOR HOME USE (Mise à la consommation)</p>	<p>The Customs procedure which provides that imported goods enter into free circulation in the Customs territory upon the payment of any import duties and taxes chargeable and the accomplishment of all the necessary Customs formalities.</p> <p><i>Note</i></p> <p>Clearance for home use is dealt with in Annex B.1. to the Kyoto Convention of 1974 and Specific Annex B, Chapter 1 of the revised Kyoto Convention.</p>
<p>CN22/23 (CN22/23)</p>	<p>The special declaration forms for postal items as described in the Acts of the Universal Postal Union currently in force (*).</p> <p>(*) Specific Annex J, Chapter 2 of the revised Kyoto Convention.</p>

TERMS	GLOSSARY OF INTERNATIONAL CUSTOMS TERMS
<p>COMMERCIAL FRAUD (Fraude commerciale)</p>	<p>Any offence against statutory or regulatory provisions which Customs is responsible for enforcing, committed in order to :</p> <ul style="list-style-type: none"> - evade, or attempt to evade, payment of duties/levies/taxes on movements of commercial goods; <p>and/or</p> <ul style="list-style-type: none"> - evade, or attempt to evade, any prohibition or restrictions applicable to commercial goods; <p>and/or</p> <ul style="list-style-type: none"> - receive, or attempt to receive, any repayments, subsidies or other disbursements to which there is no proper entitlement; <p>and/or</p> <ul style="list-style-type: none"> - obtain, or attempt to obtain, illicit commercial advantage injurious to the principle and practice of legitimate business competition. <p><i>Note</i></p> <p>A list of commercial fraud case types is included in Chapter II of the CCC Manual on measures to combat commercial fraud.</p>
<p>COMPENSATING PRODUCTS (Produits compensateurs)</p>	<p>Products :</p> <ul style="list-style-type: none"> (a) obtained within a country resulting from the manufacturing, processing or repair of the goods for which the use of the inward processing procedure is authorized; or (b) obtained abroad and resulting from the manufacturing, processing or repair of goods for which the use of the outward processing procedure is authorized (*). <p><i>Note</i></p> <p>In some countries the products obtained from the treatment of imported, exported or domestic goods identical in description, quality and technical characteristics to those temporarily admitted for inward processing or temporarily exported for outward processing, as the case may be, are deemed to be compensating products (setting-off with equivalent goods).</p> <p>(*). Annexes E.6. And E.8. to the Kyoto Convention of 1974 and Specific Annex B, Chapter 2 and Specific Annex F, Chapters 1 and 2 of the revised Kyoto Convention.</p>
<p>COMPROMISE SETTLEMENT (Transaction)</p>	<p>An agreement under which the Customs, being so empowered, consent to waive proceedings in respect of a Customs offence subject to compliance with certain conditions by the person(s) implicated in that offence.</p> <p><i>Notes</i></p> <ol style="list-style-type: none"> 1. Compromise settlement of a Customs offence is dealt with in Annex H.2. to the Kyoto Convention of 1974 and Specific Annex H, Chapter 1 of the revised Kyoto Convention. 2. See also "Administrative settlement of a Customs offence".

TERMS	GLOSSARY OF INTERNATIONAL CUSTOMS TERMS
<p>CONTAINER (Conteneur)</p>	<p>An article of transport equipment (lift-van, movable tank or other similar structure):</p> <ul style="list-style-type: none"> (i) fully or partially enclosed to constitute a compartment intended for containing goods, (ii) of a permanent character and accordingly strong enough to be suitable for repeated use, (iii) specially designed to facilitate the carriage of goods, by one or more modes of transport, without intermediate reloading, (iv) designed for ready handling, particularly when being transferred from one mode of transport to another, (v) designed to be easy to fill and to empty, and (vi) having an internal volume of one cubic metre or more. <p>"Container" shall include the accessories and equipment of the container, appropriate for the type concerned, provided that such accessories and equipment are carried with the container. The term "container" shall not include vehicles, accessories or spare parts of vehicles, or packaging or pallets. "Demountable bodies" shall be regarded as containers.</p> <p><i>Notes</i></p> <ol style="list-style-type: none"> 1. Temporary admission facilities for containers are dealt with in the Istanbul Convention (Annex B.3.) and in the Customs Convention on Containers, 1972. The latter Convention also stipulates the conditions for the acceptance of containers for international transport under Customs seal. 2. The Customs Convention on the international transport of goods under cover of TIR carnets, 1975, also deals with the use of containers in international Customs transit.
<p>CONTAINER CONVENTION (Convention sur les conteneurs)</p>	<p>The expression commonly used to refer to the Customs Convention on Containers, concluded in Geneva in 1972 under the auspices of the United Nations and administered by the Customs Co-operation Council.</p>
<p>COORDINATED BORDER MANAGEMENT (CBM) (Gestion coordonnée des frontières - GCF)</p>	<p>Coordinated Border Management (CBM) refers to a coordinated approach by border control agencies, both domestic and international, in the context of seeking greater efficiencies over managing trade and travel flows, while maintaining a balance with compliance requirements.</p>
<p>CORRESPONDING ISSUING ASSOCIATION (Association émettrice correspondante)</p>	<p>An issuing association established in another Contracting Party and affiliated to the same guaranteeing chain.</p> <p><i>Note</i></p> <p>This term is defined in Annex A to the Istanbul Convention.</p>

TERMS	GLOSSARY OF INTERNATIONAL CUSTOMS TERMS
<p>COUNTRY OF ORIGIN OF GOODS (Pays d'origine des marchandises)</p>	<p>Country in which the goods have been produced or manufactured, according to the criteria laid down for the purposes of application of the Customs tariff, of quantitative restrictions or of any other measure related to trade (*).</p> <p><i>Note</i></p> <p>In this definition the word "country" may include a group of countries, a region or a part of a country.</p> <p>(*) Annex. D.1. to the Kyoto Convention of 1974 and Specific Annex K, Chapter 1 of the revised Kyoto Convention.</p>
<p>CPD CARNET (Carnet CPD)</p>	<p>An international Customs document which incorporates an internationally valid guarantee and may be used, in lieu of national Customs documents and as security for import duties and taxes, to cover the temporary admission of means of transport and, where appropriate, the transit of means of transport. It may be accepted for controlling the temporary exportation and re-importation of means of transport but, in this case, the international guarantee does not apply.</p> <p><i>Note</i></p> <p>The CPD (Carnet de Passage en Douane) carnet is issued under the terms of the Istanbul Convention, the Customs Convention on the temporary importation of private road vehicles, the Customs Convention on the temporary importation of commercial road vehicles and the Customs Convention on the temporary importation for private use of aircraft and pleasure boats.</p>
<p>CREW'S EFFECTS (Effets de l'équipage)</p>	<p>Items in everyday use and any other articles belonging to the crew, carried on board a means of transport, and which may be required to be declared to Customs.</p> <p><i>Notes</i></p> <ol style="list-style-type: none"> 1. The Annex to the Convention on Facilitation of International Maritime Traffic, London, 1965, provides for a Crew's effects declaration (Model Form IMO FAL Form 4). 2. The declaration required by the Customs may be oral or in written form.

<p>CUSTOMS (Douane)</p>	<p>The Government Service which is responsible for the administration of Customs law and the collection of duties and taxes and which also has the responsibility for the application of other laws and regulations relating to the importation, exportation, movement or storage of goods (*).</p> <p><i>Notes</i></p> <ol style="list-style-type: none"> 1. This term is also used when referring to any part of the Customs Service or its main or subsidiary offices. 2. This term is also used adjectivally in connection with officials of the Customs, duties and taxes or control on goods, or any other matter within the purview of the Customs (Customs officer, Customs duties, Customs office, Customs declaration). <p>(*) General Annex, Chapter 2 of the revised Kyoto Convention.</p>
<p>CUSTOMS APPROVED ROUTE (Route légale douanière)</p>	<p>Any road, railway, waterway, airway and any other route (pipeline, etc.), which must be used for the importation, Customs transit and exportation of goods.</p>
<p>CUSTOMS CLEARING AGENT (Agent en douane)</p>	<p>A person who carries on the business of arranging for the Customs clearance of goods and who deals directly with the Customs for and on behalf of another person (*).</p> <p><i>Notes</i></p> <ol style="list-style-type: none"> 1. Examples of Customs clearing agents are Customs agents, Customs brokers and freight forwarders. 2. Some countries require that Customs clearing agents or Customs brokers be approved or licensed by the Customs. 3. See also the term "Third party". <p>(*) Annex G.2. to the Kyoto Convention of 1974.</p>
<p>CUSTOMS CONTROL (Contrôle de la douane)</p>	<p>Measures applied by the Customs to ensure compliance with Customs law (*).</p> <p><i>Note</i></p> <p>The measures may be general, e.g., in relation to all goods entering the Customs territory, or may be specifically related to, e.g.:</p> <ol style="list-style-type: none"> (a) the location of the goods; (b) the nature of the goods (liable to a high rate of duty, etc.); (c) the Customs procedure applied to the goods (Customs transit, etc.). <p>(*) General Annex, Chapters 2 and 6 of the revised Kyoto Convention.</p>

TERMS	GLOSSARY OF INTERNATIONAL CUSTOMS TERMS
<p>CUSTOMS DECLARATION (Déclaration en douane)</p>	<p>Any statement or action, in any form prescribed or accepted by the Customs, giving information or particulars required by the Customs.</p> <p><i>Notes</i></p> <ol style="list-style-type: none"> 1. This term includes declarations made through electronic means. 2. This term also covers action required on the part of passengers under the dual-channel (red/green) system.
<p>CUSTOMS DUTIES (Droits de douane)</p>	<p>Duties laid down in the Customs tariff to which goods are liable on entering or leaving the Customs territory (*).</p> <p>(*) General Annex, Chapters 2 and 4 of the revised Kyoto Convention.</p>
<p>CUSTOMS ENFORCEMENT NETWORK (CEN) (Réseau douanier de lutte contre la fraude (CEN))</p>	<p>The global web-based, automated Customs enforcement system developed by the World Customs Organization (WCO) for gathering non nominal data and information which also acts as a central depository for enforcement-related information at global level.</p>
<p>CUSTOMS ENFORCEMENT NETWORK COMMUNICATION (CEN Comm) (Outil de communication du Réseau douanier de lutte contre la fraude (CEN Comm))</p>	<p>A web-based, automated communication tool developed by the World Customs Organization (WCO) to enable law enforcement agencies and other parties to exchange and disseminate information securely within a Closed User Group.</p>
<p>CUSTOMS FORMALITIES (Formalités douanières)</p>	<p>All the operations which must be carried out by the persons concerned and by the Customs in order to comply with the Customs law (*).</p> <p><i>Notes</i></p> <ol style="list-style-type: none"> 1. These formalities may include those relating to phytosanitary, veterinary, immigration, currency and licensing regulations. 2. The Customs formalities in connection with various Customs procedures and practices are dealt with in the Kyoto Convention. <p>(*) General Annex, Chapter 2 of the revised Kyoto Convention.</p>
<p>CUSTOMS FORMALITIES PRIOR TO THE LODGEMENT OF THE GOODS DECLARATION (Formalités douanières antérieures au dépôt de la déclaration de marchandises)</p>	<p>All the operations to be carried out by the person concerned and by the Customs from the time goods are introduced into the Customs territory until goods are placed under a Customs procedure (*).</p> <p>(*) Specific Annex A, Chapter 1 of the revised Kyoto Convention.</p>

TERMS	GLOSSARY OF INTERNATIONAL CUSTOMS TERMS
<p>CUSTOMS FRAUD (Fraude douanière)</p>	<p>Any act by which a person deceives, or attempts to deceive, the Customs and thus evades, or attempts to evade, wholly or partly, the payment of duties and taxes or the application of prohibitions or restrictions laid down by Customs law or obtains, or attempts to obtain, any advantage contrary to Customs law, thereby committing a Customs offence (*).</p> <p><i>Notes</i></p> <ol style="list-style-type: none"> 1. In some countries, deceiving Customs constitutes Customs fraud only when it is intentional. 2. Deceit through an act of omission may or may not be regarded as Customs fraud. 3. In some countries or Customs territories, certain offences against statutory and regulatory provisions enforced or administered by Customs administrations on behalf of other government agencies are not considered as Customs fraud. <p>(*) Nairobi Convention.</p>
<p>CUSTOMS FRONTIER (Frontière douanière)</p>	<p>The boundary of a Customs territory.</p>
<p>CUSTOMS LAW (Législation douanière)</p>	<p>The statutory and regulatory provisions relating to the importation, exportation, movement or storage of goods, the administration and enforcement of which are specifically charged to the Customs, and any regulations made by the Customs under their statutory powers (*).</p> <p><i>Note</i></p> <p>Customs law generally includes provisions concerning:</p> <ul style="list-style-type: none"> - the functions, powers and responsibilities of the Customs, as well as the rights and obligations of the persons concerned, - the various Customs procedures, together with the conditions and formalities relating to their application, - the factors relating to the application of import and export duties and taxes, - the nature and legal consequences of Customs offences, - the ways and means of appeal. <p>(*) General Annex, Chapter 2 of the revised Kyoto Convention.</p>

<p>CUSTOMS MARITIME ZONE (Zone maritime douanière)</p>	<p>The sea area under the control of the Customs in accordance with their domestic legislation.</p> <p><i>Note 1</i> See also the term "Customs territory".</p> <p><i>Note 2</i> The sea area under Customs control may also include a zone continuous to the territorial sea.</p>
<p>CUSTOMS OFFENCE (Infraction douanière)</p>	<p>Any breach, or attempted breach, of Customs law (*).</p> <p>(*) Nairobi Convention and Annex H.2. to the Kyoto Convention of 1974 and Specific Annex H, Chapter 1 of the revised Kyoto Convention.</p>
<p>CUSTOMS OFFICE (Bureau de douane)</p>	<p>The Customs administrative unit competent for the performance of Customs formalities, and the premises or other areas approved for that purpose by the competent authorities (*).</p> <p>(*) General Annex, Chapter 2 of the revised Kyoto Convention.</p>
<p>CUSTOMS OFFICE OF DEPARTURE (Bureau de douane de départ)</p>	<p>Any Customs office at which a Customs transit operation commences (*).</p> <p>(*) Specific Annex E, Chapter 1 of the revised Kyoto Convention.</p>
<p>CUSTOMS OFFICE OF DESTINATION (Bureau de douane de destination)</p>	<p>Any Customs office at which a Customs transit operation is terminated (*).</p> <p>(*) Specific Annex E, Chapter 1 of the revised Kyoto Convention.</p>

<p>THIRD PARTY (Tiers)</p>	<p>Any person who deals directly with the Customs, for and on behalf of another person, relating to the importation, exportation, movement or storage of goods (*).</p> <p>(*) General Annex, Chapter 2 of the revised Kyoto Convention.</p>
<p>TRADE FACILITATION (Facilitation des échanges)</p>	<p>The simplification and harmonization of international trade procedures, including activities, practices, and formalities involved in collecting, presenting, communicating, and processing data required for the movement of goods in international trade.</p> <p><i>Note</i></p> <p>This concept refers to the WTO definition of trade facilitation</p>
<p>TRANSACTION VALUE (Valeur transactionnelle)</p>	<p>This is the prime method for determining the Customs value as defined in the WTO Valuation Agreement. It is based on the price actually paid or payable for the goods when sold for export to the country of importation (Article 1 of the WTO Valuation Agreement), adjusted in accordance with the provisions of Article 8 of the WTO Valuation Agreement.</p>
<p>TRANSFER PRICING (Fixation des prix de transfert)</p>	<p>A neutral concept that refers to the determination of transfer prices for transactions between related parties.</p>
<p>TRANSHIPMENT (Transbordement)</p>	<p>Customs procedure under which goods are transferred under Customs control from the importing means of transport to the exporting means of transport within the area of one Customs office which is the office of both importation and exportation.</p> <p><i>Note</i></p> <p>Transshipment is dealt with in Annex E.2. to the Kyoto Convention of 1974 and in Specific Annex E, Chapter 2 of the revised Kyoto Convention.</p>

<p>TRANSIT BOND-NOTE (Acquit-à-caution de transit)</p>	<p>National Customs document providing authority for goods to be conveyed in Customs transit without prior payment of import duties and taxes, generally containing all the particulars necessary for the assessment, where appropriate, of import duties and taxes, and an undertaking, covered by security, to produce the goods at the Customs office of destination with Customs seals intact.</p>
<p>TRANSPORT-UNIT (Unité de transport)</p>	<p>Any means of transporting goods suitable for use in a Customs transit operation or under Customs seal.</p> <p><i>Notes</i></p> <p>1. The term transport-unit means :</p> <ul style="list-style-type: none"> (a) containers having an internal volume of one-cubic metre or more, including demountable bodies; (b) road vehicles, including trailers and semi-trailers; (c) railway coaches or wagons; (d) lighters, barges and other vessels; and (e) aircraft (*). <p>(*) Specific Annex E, Chapter 1 of the revised Kyoto Convention.</p> <p>2. Approval of transport-units for transport of goods under Customs seal is dealt with in various international instruments, for example, the Kyoto Convention of 1974 (Annex E.1.), the Customs Convention on Containers, 1972, and the Customs Convention on the international transport of goods under cover of TIR carnets (TIR Convention), 1975.</p>
<p>TRAVELLER (Voyageur)</p>	<p>1. Any person who temporarily enters the territory of a country in which he or she does not normally reside ("non-resident") or who leaves that territory; and</p> <p>2. any person who leaves the territory of a country in which he or she normally resides ("departing resident") or who returns to that territory ("returning resident") (*).</p> <p>(*) Specific Annex J, Chapter 1 of the revised Kyoto Convention.</p>

<p>UNIQUE CONSIGNMENT REFERENCE (UCR) (Référence unique de l'envoi - RUE)</p>	<p>The Unique Consignment Reference (UCR) is a reference number for Customs use and may be required to be reported to Customs at any point during a Customs procedure.</p>
<p>URGENT CONSIGNMENTS (Envois urgents)</p>	<p>Goods which require rapid clearance as a matter of priority due to :</p> <ul style="list-style-type: none"> - their nature; - their meeting a fully justified urgent need. <p><i>Note</i> Urgent consignments should be granted priority and rapid clearance.</p>

<p>WCO DATA MODEL (Modèle de données de l'OMD)</p>	<p>A compilation of clearly structured, harmonized, standardized and reusable sets of data definitions and electronic messages to meet operational and legal requirements of cross-border regulatory agencies, including Customs, which are responsible for border management.</p>
<p>WTO VALUATION AGREEMENT (Accord de l'OMC sur l'évaluation)</p>	<p>The expression commonly used to refer to the Agreement on Implementation of Article VII of the General Agreement on Tariffs and Trade 1994, which sets out the methodology and requirements for determining the Customs value for imported goods subject to ad valorem duties.</p>
