- (1) The Convention entered into force on 10 September 1971, three months after its signature, without reservation, by five States. From that date onwards it enters into force, for any State which has signed it without reservation, ratifies or accedes to it, three months after the date of signature without reservation or of deposit of the instrument of ratification or accession.
